SPECIAL RULES AND REGULATIONS

Before the final hearing is held by the Board of Supervisors on a petition to open, alter or abandon a road, the County Road Committee views the premises.

A fee of two hundred and fifty dollars (\$250.00) **shall** be required on all petitions to open, alter or abandon a road to reimburse the county for expense incurred in case the petition is finally denied.
