Diversion Process

Youth receives a citation from law enforcement.
County Attorney receives reports from law enforcement.
County Attorney determines if youth is diversion eligible and makes referral
Diversion staff receives a copy of referral forms.
Parent or juvenile contacts the diversion office to schedule a pre-assessment.
Diversion staff determines the level of services depending on type of offense and pre-assessment outcome.
Diversion staff contacts parent regarding the level of diversion their son/daughter must enroll in.
Diversion intake is scheduled.
Upon successful completion of all program requirements, the juvenile case is dismissed and case is sealed.
